Format: 18 Holes of Stroke Play Qualifying to determine Match Play Seeds. Defending Champion Receives #1 Seed. Deadline for Entry: July 5

### STROKE PLAY

July 28-29

Format: 36 Holes of Stroke Play. Flights determined by scores and number of entries. Deadline for Entry: July 23

### SENIOR STROKE PLAY

**Kittyhawk Golf Center**  
July 26-27

Format: 36 Holes of Stroke Play. Flights determined by age. Deadline for Entry: July 20

### ADDITIONAL INFORMATION

- **Entry Fees:** \$75 or \$65 for Dayton Pass Holders. Includes greens fees, range balls before each round and \$10 credit to restaurant. Carts may be rented for \$14 per round. \$135 if a senior plays in both divisions of stroke play.
