



Dear League Secretary,

Thank you for your interest in league play at the City of Dayton Golf Courses. We look forward to seeing you in 2019!

The attached 2019 Registration Form, League Roster and League Fees for both league halves are due on or before March 1, 2019.

Our 2019 golf league schedule is divided into two halves. If you play at multiple locations, a registration form and separate payment is required for each location. There are currently no greens fee or cart fee rate changes. All pre-paid punches on the Frequent Flyer Punch Pass purchased in 2018 expired on 12/31/2018. Any punch passes purchased prior to January 1, 2018 remain available for use.

Be sure to include your league fee (make checks payable to the City of Dayton) along with the registration form and player roster. We also accept cash and credit cards if paying in person.

Pre-season ProShop hours are 9:00am to 5:00pm weather permitting; if courses are closed the ProShop is open from 10:00am to 2:00pm. **If we do not receive your registration and payment for both halves before March 1st, you may lose your current league time.**

As league secretary, please submit an updated league roster to the GOLF SHOP prior to each half of the league season. Also, we ask that you relay the following important policies to your league participants:

- Receipts for play must be presented to starter before each round
- Dress code (shirts must have sleeves)
- All alcoholic beverages consumed on the premises (including the parking areas) must be purchased at the Restaurant. Ohio law does not allow for alcoholic beverages to be brought onto the course.
- One "single rider" cart per group
- Pace of play is 2 hours 15 minutes for nine holes
- Please remember to Rake Bunkers, Repair Ball Marks and Replace Divots
- All other rules and regulations set forth by the City of Dayton (available in pro-shop)
